Update on recent developments

Ealing has local government elections on 5 May 2022: Are you registered to vote?

The Council discussed budget proposals at a cabinet meeting and will decide on 1st March about a proposed 1.99% increase. <u>The cabinet report is available online.</u> Cabinet also discussed whether to add the government's 1% social care precept to council tax bills — as a separate charge, it can only be spent on providing social care for adults. The 1% rise proposed would generate around £1.5million extra for Ealing.

Campaigns – current or upcoming

A well-attended public meeting was organised virtually by the campaign for a National Care Support & Independent Living Service (NaCSILS) on 3 February to discuss how to "End Social Care Disgrace", with speakers from the National Pensioners Convention, UNITE & Care & Support Workers Organise!, Keep Our NHS Public and disabled activist and author - Don O'Neal. For an audio version of the event - https://anchor.fm/nacsils ERSCAG is part of this national campaign and will be working to promote NaCSILS's seven principles during the forthcoming hustings for local elections and afterwards.

The local elections will also provide an opportunity for ERSCAG to push its campaigning to Scrap Social Care Charges – more information to follow in coming few months.

A national Day of Action is planned on 26 February. Locally Ealing Save Our NHS (ESON) is organising a demo outside Ealing Hospital (between noon and 1.30) calling for (a) emergency NHS funding to save lives; (b) a fully publicly owned NHS & guaranteed free healthcare and (c) proper pay and conditions for NHS staff. The national Residents and Relatives Association is calling for a new legal right to maintain contact with relatives/friends in health and care settings. They have invited the Care Minister to attend an event in Parliament on 9 March to discuss this and hear from a panel of speakers, including families, about the impact of separation and isolation. - The Department of Health & Social Care has issued <u>Coronavirus (COVID-19): guidance</u> for people receiving direct payments reflecting the latest guidance on the booster programme, travel and self-isolation, and the extension of the free PPE scheme until 2023.

Do you want help with your digital needs? Anyone living in the Borough of Ealing can call a free helpline on 0808 196 5883. You will be put in contact with the Digital Champion, who

will be able to train you remotely, either online or via the telephone whichever is most appropriate. The training is free (see Around Ealing magazine spring 2022).

Social care over the longer term

After several calls for more action from government on long term reform of the social care system, there has been a deluge of recent White Papers (see November/December ERSCAG newsletter). Yet another was issued (9 February) on the Integration of health and social care: https://www.gov.uk/government/publications/health-and-social-care-integration-joining-up-care-for-people-places-and-populations. Like some of its predecessors, it is accused by critics of being full of flowery aspirations but not always very accessible or specific.
