Update on recent developments

Ealing has local government elections on 5 May 2022: the deadline for registering to vote is midnight 14 April - <u>Are you registered to vote?</u> Once registered, if you want to vote bypostal or proxy vote, the deadline is midnight 19 April. Several of the ward boundaries are changing and all election candidates have to be named by 6 April, so to check who is standing in your area see: <u>www.whocanivotefor.co.uk</u>

In March, Ealing Reclaim Social Care Action Group (ERSCAG) has attended (virtual) meetings of the Council's Adult Social Care Standing Scrutiny Panel (2 March) and of the Health and Well Being Board (16 March) and has been in correspondence with senior staff and relevant Councillors on a range of topics: provision of Lateral Flow Tests to social care users when their free supplies run out; payment of the London Living Wage to all care workers along with automatic annual uplifts; workforce shortages; the Healthwatch report into the needs of housebound residents; & the statistics underpinning decision making on social care provision.

A meeting of ERSCAG's Direct Payment User Group was organised (16 March) and Sham Baig (Ealing Direct) was the invited guest to discuss a range of issues including: the current difficulty of Direct Payment users in finding Personal Assistants; the importance of disability equality training for Council staff; and the financial worries created by care charging. She also confirmed the good news that the Council will continue to provide Personal Protective Equipment free for social care users until 2023, but the situation regarding the provision of free Lateral Flow Tests remains unclear (see news items later on).

ERSCAG joined in the Day of Action (26 February) with a local demo organised by Ealing Save Our NHS outside Ealing Hospital. Whilst the main focus was on proper funding for the NHS, we raised concerns around social care, and put the politicians present on notice that at the forthcoming local government elections they will be asked to scrap domiciliary care charges.

Campaigns – current or upcoming

Local government elections are a key moment to alert the general public, political parties, and individual candidates to the concerns of people using social care. Local authorities have primary responsibility in this area, and despite the reduction in central government funding, should be encouraged to live up fully to their responsibilities. In the lead up to 5 May, ERSCAG will work locally and nationally on this agenda.

Locally, we have developed a number of demands to raise at any hustings that are arranged, and we will be writing to all the declared candidates once their details have been confirmed. We will be asking all candidates if they support an end to charging for domiciliary care (or a freeze/moratorium in the meantime); will promote a policy of Independent Living where the

social care user is involved in the design and delivery of the service; improve pay and conditions for care staff; and argue for better financing of this whole sector from central government. If you are attending any local hustings, please raise these questions, or get in touch with ERSCAG for some more guidance, or alternatively check out: Local Election Toolkit 2022 - Inclusion London Ealing Council is currently Labour-controlled so we will ask those candidates what they will do, if elected, to comply with the local Labour Party manifesto to "fix social care". And what are the other local political parties saying about this topic?

At the national level we will be working as part of the campaign for a National Care Support and Independent Living Service (NaCSILS) and the Scrap Social Care Charging campaigns to publicise similar concerns via postcards/lobbying MPs etc.

Most of you will have followed the Chancellor's Spring Statement, and Age UK organised more than 1000 interventions in advance. While many older people and others on benefits will see their financial situation worsen in the coming period, the Age UK update noted that the organisation intended: "to keep up the pressure on the Government to make sure older people can keep their heads above water" (see <u>www.ageuk.org.uk</u>)

On 22 March, a meeting of the All-Party Parliamentary Group for Disability met with four umbrella disability groups to hear of their submissions to the United Nations Committee for the Rights of People with Disabilities (UNCRPD). Inclusion Scotland, Disability Wales and Disability Action Northern Ireland all raised concerns and spoke of some legal advances; but the English contributors noted that they had little positive to report – there was a feeling that covid had seen a real regression in attitudes to, and treatment of, disabled people.

Campaigning for the London Living Wage for Personal Assistants and care workers, Citizens **UK** has called for a tea party on 30th March outside parliament to support care workers, reporting that "across the South East of England, over a fifth of all care industry jobs pay less than a real Living Wage? That's 34,000 workers barely earning enough to get by".

At the end of last month, government issued two important reports - Social care reform: an independent review by Baroness Cavendish and Social care reform: government response to Lords Select Committee report. ERSCAG has yet to study them closely to understand better what government is planning to do about social care policy over the longer term.
