

# Update on latest activities

The most important development at national level since the last ERSCAG newsletter was the announcement of the Budget, though its silence on the issue of adult social care was deafening! ERSCAG and others will have to step up their campaigning to make this a more important issue in the minds of our elected politicians and local and national policy makers. This silence about future social care funding is all the more surprising on studying a recent letter from Ealing Council to residents about the increase in Council tax for 2023/2024. They wrote *"around 60p in every £ that the council spends goes towards supporting older adults or people with disabilities and children in need of care.....social care continues to be the biggest bill that the council pays with costs rising every year as more people need support. We know we need to fix social care in the long term".* 

The same Council letter focused on the cost-of-living crisis for many Ealing residents. Thanks to earlier interventions by ERSCAG and others, Council staff have ensured a dedicated element of the council's website addresses the particular needs of disabled people, as well as older people and families (see on for link).

Ealing Reclaim Social Care Action Group (ERSCAG) exists to advocate for changes to the system, and to support the Council in its efforts to provide good adult social care. This month, that involved ERSCAG asking questions at the Health and Wellbeing Board about pay rates to domiciliary carers working across Borough boundaries, and expressing concern about the lack of detail provided regarding the funding and staffing required if the Council is to implement its well-received All-Age Learning Disability Strategy.

## Campaigns - current or upcoming

As mentioned last month, a very important zoom event was convened to discuss the needs of carers. The testimony provided by several carers looking after family members was extremely powerful, and there was a lively discussion about how the needs of family and informal carers could be effectively met – see: <u>https://fb.watch/jotxZ9lhDF/</u>. And while we are talking of carers, the newsletter editor recently noticed that Bloom & Wild (florists) is actively supporting the Carers' Trust (<u>www.carers.org</u>). Bloom and Wild (<u>www.bloomandwild.com</u>), in their deliveries, alert customers to the fact that there are "7 million unpaid carers in the UK, many of whom give up their careers, their education, their ambitions and their free time to care wholeheartedly for someone they love" and they promise that "every time someone buys our Florists' Pick, we'll donate 15% of the profit to Carers Trust".

Age UK, Independent Age, the Centre for Ageing Better and the National Pensioners Convention have issued a consensus statement urging the creation of a Commissioner for Older People & Ageing. For more information and to sign up to the campaign – see <u>https://campaigns.independentage.org/page/124541/petition/1?ea.tracking.id=npc</u> Last month the newsletter promoted the major demonstration organised in support of the NHS – if you were not able to attend you may be interested in this report from Keep Our NHS Public: "What a fantastic day Saturday 11 March was. It was an incredibly lively and sometimes moving demonstration which including a tearful minute's silence for Covid victims at the start. The demonstration was called to demand that the government act now to end the extreme crisis in the NHS, a crisis which is causing hundreds of unnecessary and preventable deaths every week.....the many thousands of protestors were addressed by politicians, leading trade unionists, strikers and campaigning groups ...".

There are no elections due locally for a while, but other parts of the country will be having Council and/or County Council elections in May. Remember that new arrangements now apply and the government has issued the following guidance for those supporting anyone voting at polling stations – <u>please make sure they bring photo ID for the local elections 4 May</u> – and reminds us that the deadline to register to vote is 17 April 2023. - Age UK report their "deep disappointment about the lack of money for care" <u>read Caroline</u>, <u>our Charity Director's</u>, <u>statement</u>. Elsewhere, however, they did note how they had been lobbying hard prior to the Budget on the <u>unfairness of pre-payment meters</u>; handed in a petition to the Chancellor with 31,186 signatures; secured a meeting with the Department of Health and Treasury where they spoke of older people's experiences waiting for care; and gained <u>huge coverage in national media</u> about the effect of social care waiting lists on older people's quality of life.
