

Ealing Reclaim Social Care Action Group Newsletter June 2023

Update on latest activities

ERSCAG attended the national launch of the Fabian Society Study (see page 4) and a range of Ealing Council meetings (the Health and Wellbeing Board and Ealing Health & Care Residents Forum), as well as the – slightly more fun – distributing our leaflets at the Hanwell Carnival for its 125th anniversary! Hopefully we will be at Acton Carnival and other local events over the summer too.

The new chair (Cllr Ben Wesson) of the Council's Health and Adult Social Care Scrutiny Panel kindly invited ERSCAG to join in the work of the Panel as a co-optee for the coming year. Whilst our limited resources prevented us taking up the offer — we were delighted, seeing this invitation as a signal that the Panel wants to give continued, and hopefully increased, priority to social care alongside its scrutiny of health provision in the Borough. Like his excellent predecessor before him (Cllr Dan Crawford), we hope to invite Cllr Wesson to a future event to hear directly from social care users about their concerns.

One of the many issues to raise at future Council events will be the funding of social care, so it was notable that the quarterly (May 2023) summary by the Ealing Advice Service (www.ealingadvice.org) reported that one of the key issues brought to the attention of their case-workers was the "overzealous enforcement of care charges". Campaigners are hopeful that the Equality and Human Rights Commission, at the national level, may make care charging a future priority, and ERSCAG will push for the sharing of good practice at Council level. Our neighbouring Council, Hammersmith & Fulham Council, ended care charging entirely, and colleagues in (far-off!) Lewisham have been drawing on this experience with a recent report by its Lewisham Disabled People's Commission.

A meeting of our Direct Payment User Group was held (21 June) and we had a speaker from Inclusion London introducing their helpful new online tool to determine Disability Related Expenditures – see Reduce your social care charges today See also the conclusions of a court case where the judge has ruled (PDF) that Windsor and Maidenhead council behaved unlawfully by refusing to view activities the man attended as part of a social and life skills group as "disability-related" spending.

Campaigns – current or upcoming

End Social Care Disgrace is organising an important virtual meeting on 10th July – following on from their very successful meeting held on carers. 75th **anniversary of the NHS:** on Saturday Ist July there will be a birthday celebration with speakers outside Ealing Hospital. The anniversary has also seen a number of new books – including "Fighting for Life: the twelve battles that made our NHS and the struggle for its future", by Isabel Hardman; and "Our NHS: a history of Britain's best loved institution" by Andrew Seaton. The Daily Telegraph and Guardian both reviewed them, the latter reporting positively: "Harman is a meticulous journalist with a gift for storytelling" and describes the Seaton book as "more academic but still accessible survey of health service history". The Telegraph additionally reviewed (positively) "Our Stories: 75 years of the

NHS from the people who built it, lived it and loved it" by Professor Stephanie Snow; and (negatively) "Why the NHS is being betrayed and how we can fight for it" by Dr Julia Patterson.

The Residents and Relatives Association are merging with the Rights for Residents campaign group to create "Care Rights UK" as a voice for people needing care (www.carerightsuk.org) and Age UK reported on the new Carer's Leave Act that gives employees a new right to five days unpaid leave to care for older, disabled or seriously ill relatives or friends. For those juggling work with their responsibilities as a carer, this is a lifeline, but is unpaid.

 annual average real increase in spending since it was founded in 1948. As former health
 secretary Jeremy Hunt admitted last year, Cuts to social care also "went too far". When you
 adjust for an ageing and growing population, as esteemed professor of epidemiology Sir
 Michael Marmot puts it, NHS spending actually went down.

The United Nations Committee on the Rights of Persons with Disabilities (UNCRPD) has issued a call for evidence (deadline 1 August). UN committees examine the UK government's compliance with its international obligations and made a number of disability related recommendations back in 2016 – see the original report here. Organisations can submit written evidence by 1 August 2023 or can share evidence in-person as part of the oral briefing on 28 August 2023. Social care over the longer term

As noted in ERSCAG's May newsletter "It will be interesting to see what all the main political parties agree as part of their policy positions at their conferences later this year and in the lead up to the elections next year". So far, we are aware of some party conference dates (Lib Dems 23-26 September in Bournemouth; Conservatives 1-4 October in Manchester; and Labour 8-11 October in Liverpool).

Presumably the Conservative Party position on long term funding for care can be assessed on the basis of the most recent government response to a parliamentary committee:

Wes Streeting, Labour party Shadow Secretary of State for Health and Social Care, when asked about the NHS on its 75th anniversary said: "It requires three big shifts: from an excessive focus on hospital care to more focus on neighbourhood and community services; from an analogue to service to one that embraces the technological revolution; and from sickness to prevention. If it does all three things, it will be an NHS fit for the future". It is difficult to meet these objectives without very serious investment in social care, and this point will be reiterated by ERSCAG and others in coming months.

ERSCAG still has to comment in detail, but welcomes the commitments to supporting co-production, extending rights, investing in skills and improving pay and conditions of the workforce, supporting carers, and creating a common 'brand' of a National Care Service alongside the NHS with less of a national postcode lottery. Like others, however, ERSCAG is very concerned about a number of the study's failures: to reflect the urgency of the change needed; to give detail on principles like co-production; and, in particular, to make bold proposals about funding. We need a social care service that is publicly funded and free at the point of use and will continue to campaign to that end.
