

# Ealing Reclaim Social Care Action Group Newsletter July/August 2023

## **Update on latest activities**

Ealing Reclaim Social Care Action Group (ERSCAG) made a short submission in July to the United Nations Committee on the Rights of Persons with Disabilities (UNCRPD) urging them, when examining the UK government's compliance with the UN Convention, to ask probing questions about social care.

Much closer to home (!), we attended meetings of the Council's Health and Well Being Board, the Health and Adult Services Scrutiny Panel (13 July), and the Ealing Health and Care Residents Forum (8 August). Questions were asked about recruitment and retention of staff, backlogs in care assessments, co-production (defined in a recent British Institute of Human Rights newsletter late July/early August as "Co-production is when service-providers work alongside people accessing or trying to access services to ensure the service best meets everyone's needs"), and digital exclusion (see on to campaigning and NPC. At the Residents Forum, useful material was shared about end-of-life treatments (see on)

Members of ERSCAG and its Direct Payment User Group (DPUG) attended sessions run by Inclusion London (9 August) about reducing social care charges, and their Chatbot is available for Direct Payment people to use. A very useful meeting was held (14 July) with Council and NHS staff to discuss improved collaboration in terms of communications with Direct Payment and Continuing Healthcare users.

Enjoying the brief summer sunshine, ERSCAG was invited by Ealing Save Our NHS, along with other community groups and campaigners, to speak at the demo (1 July) held outside of Ealing Hospital to mark the 75<sup>th</sup> NHS birthday; and we distributed our leaflets at the Acton Carnival.

For any party-political activists attending party conferences this Autumn, please see final section – social care needs to move up the political agenda. Many of our exchanges with politicians say "we do not hear about social care on the doorsteps" and explains why the issue does not get the political and financial priority it requires.

## Campaigns – current or upcoming

End Social Care Disgrace campaign has organised a series of meetings looking at different aspects of social care. the care workforce but also addresses the need for longer term change: "Care has long been the forgotten service...(we) bring together employers, politicians who know about the sector and the biggest care union to make a powerful case for change. Care needs urgent and lasting reform. Paying dedicated staff who look after our elderly and vulnerable relatives a proper wage would start to transform care into a service fit for the future."

Amnesty International (UK) is launching a brand-new Disabled People's Human Rights Network. "On Saturday 23 September 2023, we want to bring together disabled people and human rights activists to talk about what disability justice means to us, and to celebrate the long history of disabled people fighting for their rights". The NPC is also one of many groups campaigning actively against the threat of railway ticket offices being closed – a measure which is bound to create problems for older and disabled people. Ealing Council's Scrutiny Panel received a report at its July meeting on the proposed closure of some 31 mental health beds in Ealing Hospital. Ealing Save Our NHS (ESON) has long campaigned against the loss of acute mental health beds for the under 65s in Ealing — with a 1000 strong petition, media work, and close liaison with campaign groups across North-West London area to challenge this major loss of services and the lack of appropriate engagement with those likely to be directly affected. The impact on carers is inestimable. ERSCAG has pledged its support to the campaign and will keep monitoring developments.

Last but not least: a national petition to link care and support worker pay to NHS banding

- New data from Skills for Care, shows that between 2022 2023, "the job vacancy rate decreased to 9.9%, or around 152,000 on any given day; international recruitment is also on the rise in the care sector, with around 70,000 people recruited from abroad into direct care provision roles. Government has unveiled a £600 million package to help with recruitment and retention in social care". Helen Whately, Minister for Social Care, has written to local authorities and care providers about preparations for winter.

## Sources of advice and help

If you have a complaint about social care provision and have not had a satisfactory response from those concerned, you may want to check out the website of the Local Government and Social Care Ombudsman (<a href="www.lgo.org.uk">www.lgo.org.uk</a>). The office produces a weekly update about investigations. Two academic articles in April by Prof Robert Thomas noted that the LGO "has become accustomed to addressing the underlying structural root causes of fault – organisational, institutional and cultural – rather than just their surface consequences for complainants". Or have you considered contacting your local MP? Rupa Huq (Ealing Central and Acton) - asked a Parliamentary Question (13 July) on the topic (see earlier) of railway ticket office closures: "Mr Speaker, you yourself said that this news has been most unwelcome for the elderly, disabled and blind. Was an impact equality assessment carried out?"

Locally, Ealing Advice Service (www.ealingadvice.org), in their most recent quarterly report found that of the 130 responses provided by service-users - 29% reported an increase in benefits, 95% said their situation had improved, 92% stated that their stress levels had improved, and 81% reported improved confidence in dealing with such issues in future.
