

# Ealing Reclaim Social Care Action Group Newsletter February 2025

### **Update on our latest activities**

Ealing Reclaim Social Care Action Group (ERSCAG) has had a busy month meeting with different Ealing Council people to discuss a variety of issues around social care in the local area. We met separately with Carleen Duffy of Ealing Healthwatch, Kerry Stevens (Strategic Director of Adult Social Services and Public Health) and Cllr Polly Knewstub (portfolio holder for healthy equal lives).

At all of these meetings, we pursued concerns around the recent Care Quality Commission (CQC) report and its findings on Ealing social care provision. Despite being disappointed at the overall rating ('requires improvement') and approach (which arguably showed little knowledge of the experience of London Boroughs), Council representatives told us that there was important learning that will be actively pursued. A focus will be on the assessment waiting lists, the needs of carers, and improved communications (via website/town hub signposting options/ and non-digital means). The CQC report will figure on the agendas of future Health and Well Being Board and Health and Adult Social Services Scrutiny Panel, and ERSCAG will monitor progress.

Another concern we raised at several of these meetings was the impact on users of social care of the Council decision to extend the Controlled Parking Zones (CPZs) and School Streets Programmes: how will care-workers get to their clients in time to provide important medication etc? It is unclear to what extent the needs of care-users, carers and care-workers have been taken into account – and we will be pursuing this. In related campaigning, we have been pursuing, both with the Council, and the London Assembly, the problems of Blue Badge thefts see local petition underway: https://www.ealinglibdems.org.uk/campaigns/blue-badge-petition

Ealing Healthwatch will be reviewing the work of Harrow Careline in coming months and ERSCAG is preparing a 'note of concerns' for them about the closure of Ealing Careline and its replacement with Harrow Careline, fearful that some vulnerable people may have inadvertently missed out on this vital emergency alarm service (see 2024 newsletters).

# Campaigns – current or upcoming national campaigns

End Social Care Disgrace is organising a public meeting (by zoom) on Thursday 13 March, 6.30-8pm. He's going after crips...At the post-crash briefing on Thursday, the president took pains to recite a list of disabilities ...in his characteristic mafia extortionist's drone, emphasizing each disability with a note of astonished distaste. They include hearing, vision, missing extremities, partial paralysis, complete paralysis, epilepsy, severe intellectual disability, psychiatric disability and dwarfism.... 'This is part of the FAA's diversity and inclusion hiring plan. which says diversity is integral to achieving FAA's mission of ensuring safe and efficient travel. I don't think so. I don't think so."

## Sources of advice and help

Ealing MPs are always available for you to raise issues of concern either by way of Written Parliamentary Questions or in their surgery offices – relatively new MP Deirdre Costigan (Ealing Southall) has recently become a Parliamentary Private Secretary in the Department of Health & Social Care; MP Rupa Huq (Ealing Central & Acton) asked a

question recently about visual impairment (see <u>Written Answers - Women and Equalities:</u> <u>Business: Visual Impairment</u>) and <u>Education</u>, <u>Health and Care Plans - [Dr Rupa Huq in the Chair]</u>; and James Murray MP (Ealing North) stays with the important Treasury Team.

A Swedish reader of our ERSCAG newsletter wrote to say that a group there called Senior Power are discussing future priorities: "We are interested in focusing on the human rights perspective related to elderly persons, particularly those in institutions. What we mean is the right to – dignity; participation and social inclusion; privacy, and non-discrimination." Sounds like a good approach?

North-West London is seeking to improve adult community specialist palliative care – ERSCAG's January newsletter 'advertised' their consultation. They now report "One area that people have asked us to provide more information on is enhanced end-of-life care beds and we have <u>published an article on our website</u> in order to do so. This covers why we are proposing their introduction and who will be providing the care and support to patients admitted to the beds."

#### Social care over the longer term

Our January newsletter reported the creation of an independent commission to look at social care, and concerns about the timescale envisaged. In contributing to this work, ERSCAG and others will have to get to grips with a lot of statistics such as: Adult social care in England, monthly statistics: January 2025; https://digital.nhs.uk/data-and-information/data-tools-and-services/data-services/adult-social-care-data-hub and the Kings Fund "Facts and Figures" which estimates that local authorities spent £28.4bn on social care in 2022/23; 818,000 people received publicly funded long-term social care in 2021/22, with a further 224,000 people receiving short-term care.
