Update on our latest activities

Ealing Reclaim Social Care Action Group (ERSCAG) held its 2025 Annual General Meeting virtually on 2nd June. A brief annual report and financial report were presented and the new committee consists of John Moffat and Brian Rose, along with re-elected members Maggie Beirne (secretary), Alex Cowan, Mike Geoghegan, Janet Mearns, David Scully, Mark Tilston (treasurer) and Roy Willis (chair). ERSCAG regularly attends official meetings of the Health and Wellbeing Board and the Health and Adult Social Services Scrutiny Panel and met with Kerry Stevens (Strategic Director of adult social services & public health) on 27 May, James Murray MP (30 May), and Cllr Polly Knewstub (Cabinet portfolio of Healthy Equal Lives) on 25 June. At all of these meetings we explored issues of concerns about the Borough's daycare provision; the impact of CPZs/School Exclusion Zones on disabled people, carers and careworkers; and user involvement in service provision etc.

Campaigns - current or upcoming national campaigns and events

Campaigners are urging people to engage in the debate about the current 'Welfare Bill' going through parliament. But many fear the exact opposite and have organised accordingly. Disability

• The April newsletter carried this item, but it seems worth repeating in light of the publication of the Welfare Bill -"For arguments in response to myths about disability benefits, see the Disability Cuts Mythbuster Information Pack which challenges persistent myths by providing statistics - (https://www.linkedin.com/search/results/all/?keywords=%23disabilitycutsmythbusters&origin=HASH_TAG_FROM_FEED&lipi=urn%3Ali%3Apage%3Ad_UNKNOWN_ROUTE_search.results.gen_eric.index%3B1gsKs6%2FlS7yClC8MZRXHig%3D%3D)- showing that: more disabled people work than don't; disabled people contribute seven times more to the economy than disability benefits cost; disabled people on benefits are much poorer on average than people who do not need benefits; PIP (Personal Independence Payment) is not an out-of-work benefit and cutting PIP will make it harder for more disabled people to work; PIP is hard for disabled people to get, not easy; people only get PIP if they are disabled and struggle to function in daily life"

- The All Party Parliamentary Group on Poverty and Inequality published its report on the disproportionate impact of poverty on disabled people (June 2025). The report follows the Department for Work and Pensions' Pathways to Work Green Paper, which has been widely criticised for cutting the incomes of disabled people, pushing 250,000 people into poverty according to the DWP's own analysis. The Joseph Rowntree Foundation estimates that this number could be at least another 150,000 higher. Social care over the longer term

The Casey review into social care started work earlier this month, with Baroness Casey meeting with carers, care-users, disabled people, and campaigners to hear their experiences of the sector and how it can be improved. The consultations will continue ahead of the first phase of work, but further details of how to get involved are yet to be announced (Frequently asked questions | Casey Commission). The terms of reference can be found here (Terms of reference | Casey Commission). ERSCAG is unclear about the extent of public consultation but has been informed that "If you wish to contact the commission to find out further detail as to how you can contribute to their findings, they can be contacted here: enquiries@caseycommission.co.uk"
